

CAREGIVERS COMES TO FILLMORE

February, 1992, marked the beginning of the initial ground-work to establish a CAREGIVERS office in Fillmore. Recognizing the need for supportive services for frail elders in their community, the managers of El Dorado Mobile Home Park, Al and Helen Rosetti, gave enthusiastic support and encouragement to the idea of having CAREGIVERS in Fillmore.

In March, Carol Basralian, our Santa Paula Coordinator, was invited to attend two Fillmore Ministerial Association meetings. After explaining the goals and mission of CAREGIVERS, Carol received the backing of the Association, with assurances that various churches will aid in the recruitment of volunteers. Pastor Patricia Litten of the Church of the Nazarene generously arranged for the donation of office space at the Church.

Good planning, widespread community support, and Carol's enthusiasm carried the day as the CAREGIVERS Board of Directors gave final approval for expansion to Fillmore. Until funding can be found for a part-time Fillmore coordinator, Carol will be staffing that office in addition to her Santa Paula duties.

In September the Fillmore office was officially opened, and five community volunteers have already stepped forward. Our thanks go to Trudy Gardner, Evelyn Spradling, Ann Burson, Nathalie Milliken and May Carter for helping CAREGIVERS move a little farther forward in our goal of bringing volunteer services to frail elders throughout Ventura County!



Craig Ploss, Chairman of the Board, and his wife, Joan, share many things in common outside of their work in the legal profession. He is a practicing attorney, and she is a legal secretary and office manger. In addition to their CAREGIVERS activities, they share an interest in animal welfare and are active members of the Humane Animal Rescue Team (H.A.R.T.). And now they are sharing grandparenthood -- a baby girl, born on September 26th to their son and daughter-in-law in San Jose.

During the process of caring for her elderly mother, who died about four years ago, Joan discovered CAREGIVERS, and volunteered in 1988. Gradually, Craig became interested in the needs of the frail elderly and volunteered his legal expertise to the program.

Craig graduated from the University of Minnesota in June, 1971, with a BA degree in Political Science. He took a long and interesting route from business to the legal field by serving as an Explosive Ordnance Disposal Officer with the U.S. Navy and then as District Manager for North Sea Operations for a civilian explosives company, based in Aberdeen, Scotland. Travel assignments took him to Alaska, Canada, England, Ireland, Egypt, South Africa, Saudi Arabia, United Arab Emirates, and Kuwait before he finally arrived in Ventura in March, 1983, as West Coast District Manager.

Looking for a change, Craig entered law school, graduated from Ventura College of Law in 1987, passed the State Bar Exam in February, 1988, and established his legal practice, emphasizing estate planning, elder law, non-profit corporation law, and real estate law.

In 1990 Craig became a member of the CAREGIVERS Board of Directors, becoming Chairman in 1991. Commenting on the lifestyle of voluntarism that he has adopted, Craig says, "Lawyers are sometimes seen as part of the problem. I want to be seen as part of the solution."

FOR YOUR INFORMATION

The Postal Alert Program is a cooperative program between the U.S. Postal Service and the Information and Referral program. The service is helpful for seniors and handicapped persons. The letter carrier is trained to spot signs of potential trouble in the house such as mail box overflow, porch lights burning all day, broken windows and other signs. To register for Postal Alert, call 653-5594.

The Ventura Minibus Service provides supplemental transportation for disabled adult residents within the Ventura City limits. Transportation is available for medical appointments, grocery shopping, and for personal business. It operates Monday through Friday from 8 AM - 4 PM. To arrange for a ride, call the dispatcher at 643-3122 from 8 AM - 4 PM, at least 24 hours in advance.

DIRECTOR'S MESSAGE

UNITED WAY DAY OF CARING

Someone recently asked a very legitimate question: "Since CAREGIVERS volunteers are paid nothing for their services, why does it cost so much to operate the program? Why do you need to raise more money every year?"

I'd like to try to respond to this common question that is asked of non-profit organizations, especially those that utilize volunteers.

The reality is that non-profits have similar expenses to any other business: we pay for rent and upkeep of our office; we pay for the telephone, postage, printing of materials, for office supplies such as pens, paper clips, stationery and file folders. In order to keep accurate records and make our program operate as efficiently as possible, we need to purchase and maintain office equipment such as computers, calculators, and a copier. We print and mail a newsletter in order to keep you informed about our activities. We also have to buy liability and Worker's Comp insurance, and we feel it is not out of line to budget a modest amount to recognize our volunteers at an annual dinner and to hold a Holiday Party for those we serve.


As in any organization, staff salaries and various government - required payroll taxes are the biggest expense. CAREGIV-ERS employs, full-time, an Executive Director and a Director of Volunteers. Part-time employees include an Associate Director of Volunteers for Fillmore and Santa Paula, a Director of Development, and an Administrative Assistant/Bookkeeper.

These CAREGIVERS staff members take care of running the "business" of the program, providing a continuity and confidentiality that would not be possible if these positions were filled by volunteers, who very rightly put their own lives, families, and vacations ahead of CAREGIVERS on their priority list.

Even though our program services are free to the recipients, our program support must be paid for. That's why we ask for your help in the form of contributions.

So many grateful people call and write us to say how a CAREGIVERS volunteer has changed their life.

Your generous contributions are needed and appreciated. Working in partnership - volunteers, donors, Board and staff-we truly make a difference in the lives of the frail elderly in our community.
